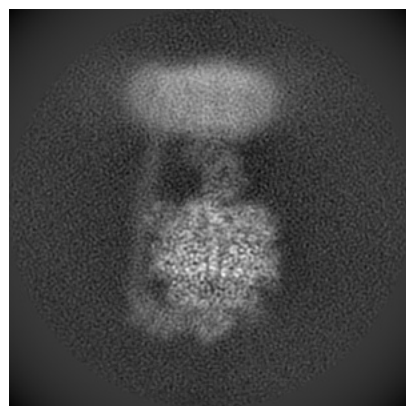
## 2 Map visualisation [i](#)

This section contains visualisations of the EMDB entry EMD-34763. These allow visual inspection of the internal detail of the map and identification of artifacts.

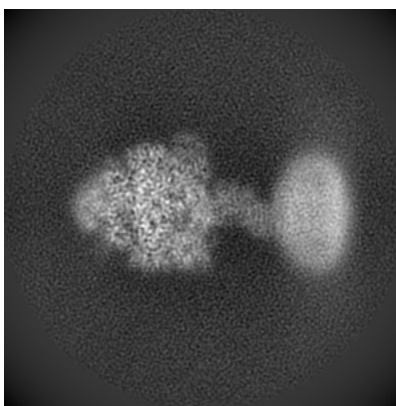

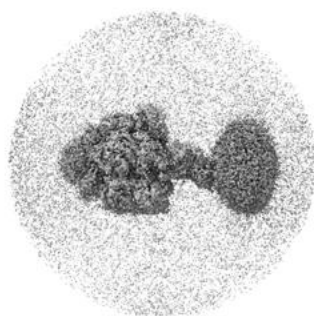

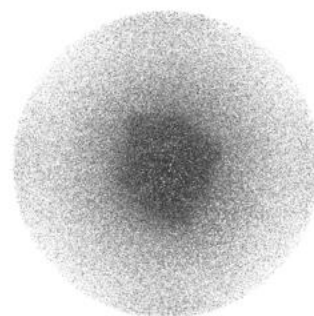

This section shows the 3D surface view of the primary map at 50% transparency overlaid with the specified mask at 0% transparency

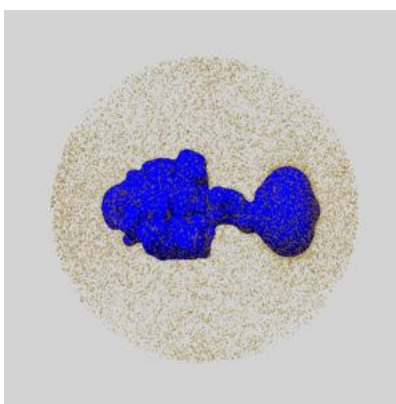
A mask typically either:

- Separates out a domain, a functional unit, a monomer or an area of interest from a larger structure

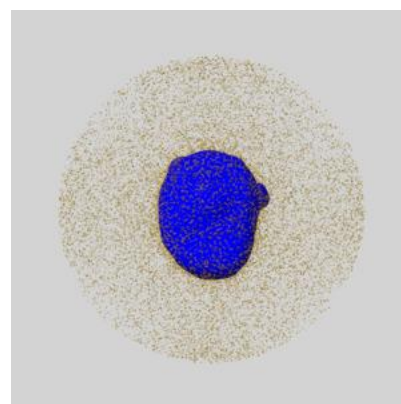

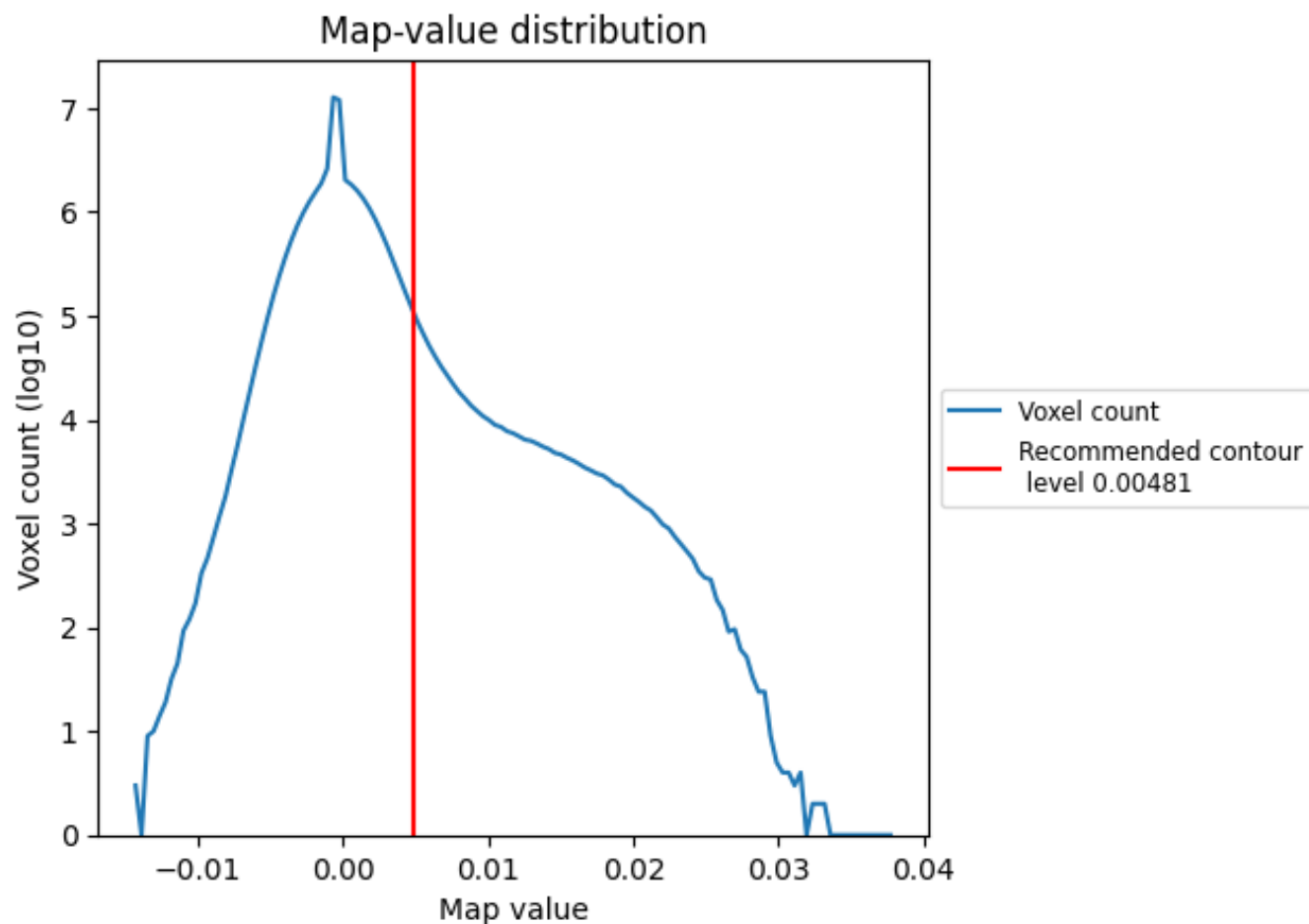

### 3 Map analysis [i](#)

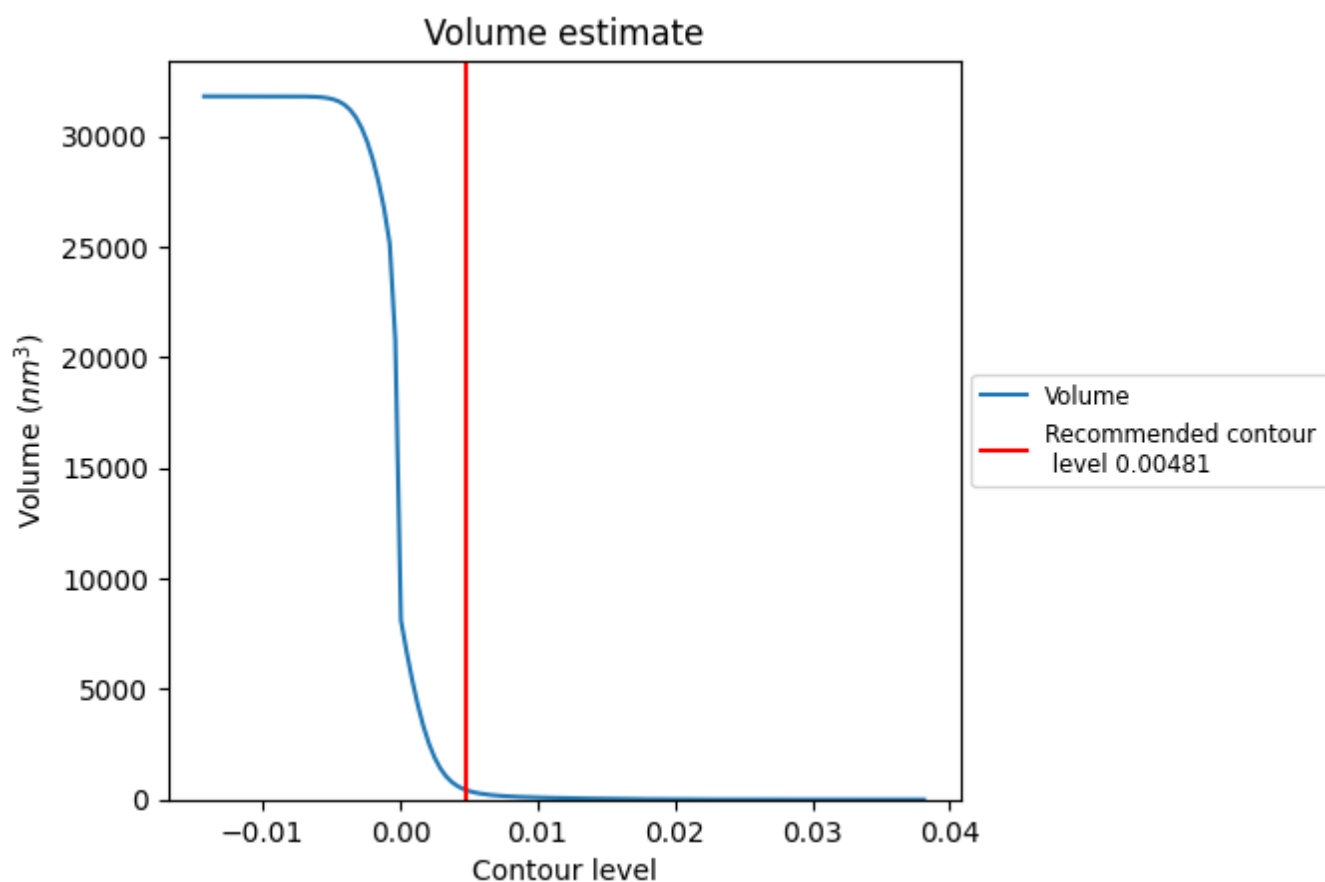
This section contains the results of statistical analysis of the map.

#### 3.1 Map-value distribution [i](#)



The map-value distribution is plotted in 128 intervals along the x-axis. The y-axis is logarithmic. A spike in this graph at zero usually indicates that the volume has been masked.

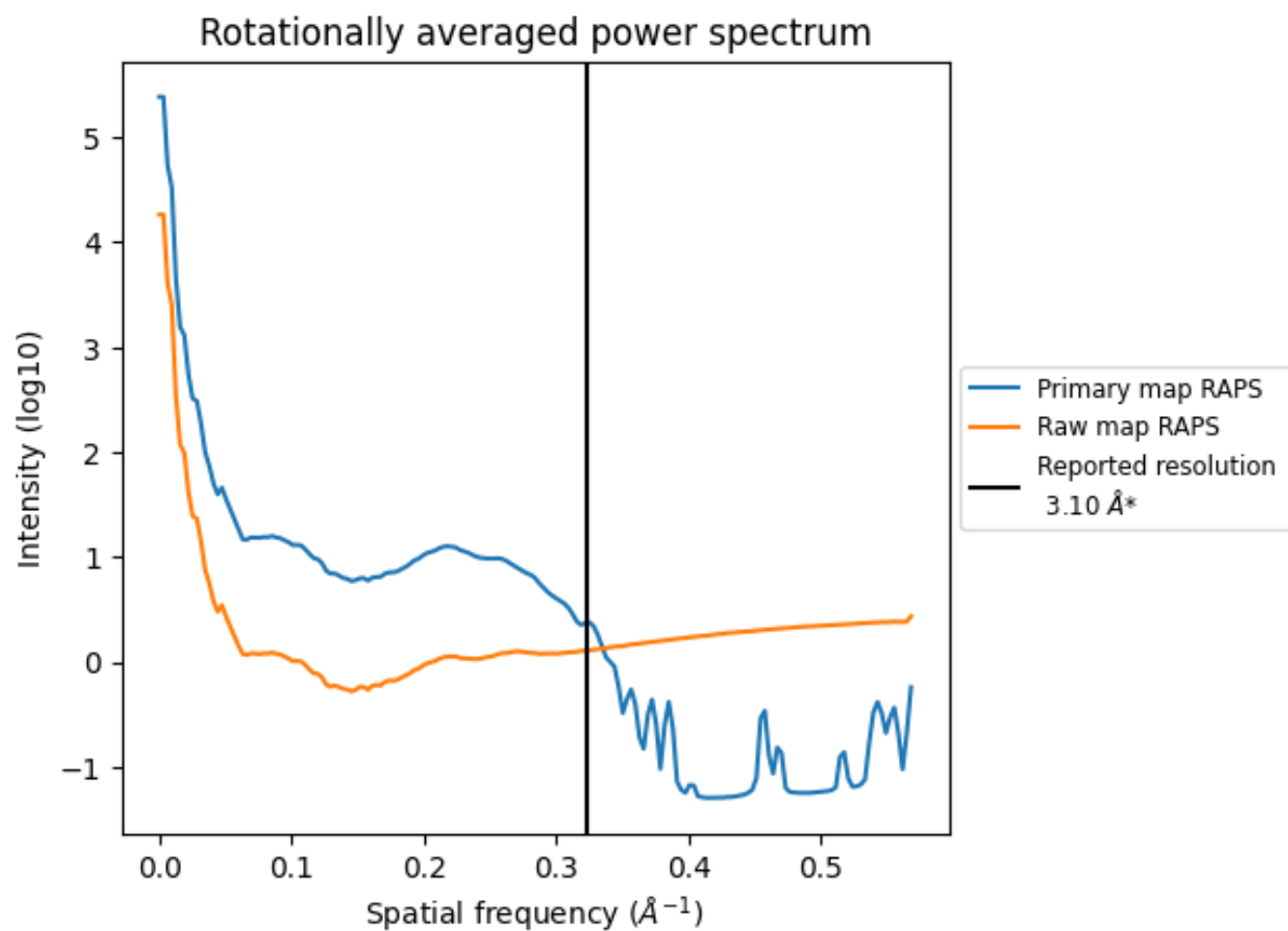
### 3.2 Volume estimate [i](#)



The volume at the recommended contour level is 433 nm<sup>3</sup>; this corresponds to an approximate mass of 391 kDa.

The volume estimate graph shows how the enclosed volume varies with the contour level. The recommended contour level is shown as a vertical line and the intersection between the line and the curve gives the volume of the enclosed surface at the given level.

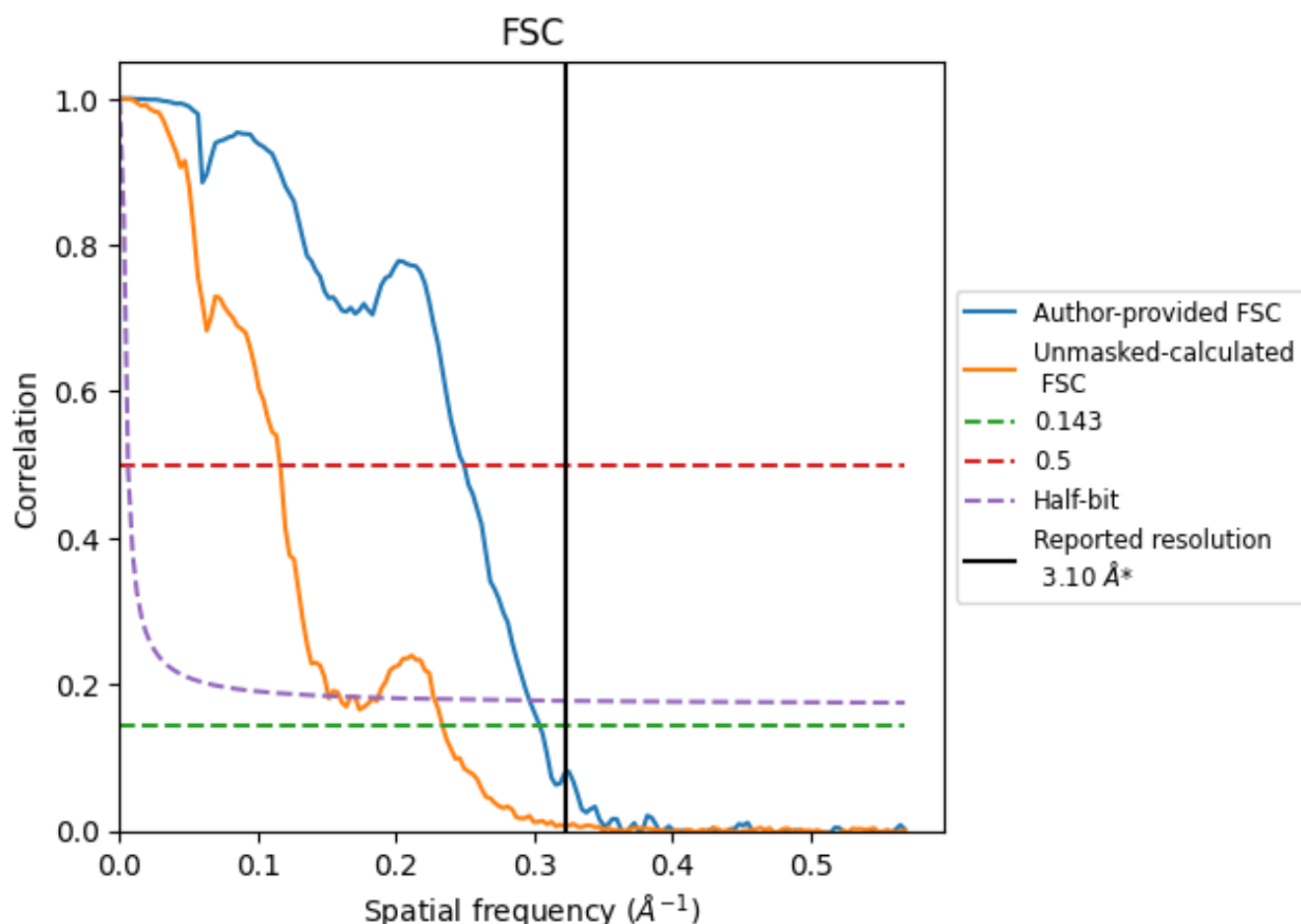

## 4 Fourier-Shell correlation [i](#)

Fourier-Shell Correlation (FSC) is the most commonly used method to estimate the resolution of single-particle and subtomogram-averaged maps. The shape of the curve depends on the imposed symmetry, mask and whether or not the two 3D reconstructions used were processed from a common reference. The reported resolution is shown as a black line. A curve is displayed for the half-bit criterion in addition to lines showing the 0.143 gold standard cut-off and 0.5 cut-off.

\*Resolution estimate based on FSC curve calculated by comparison of deposited half-maps. The value from deposited half-maps intersecting FSC 0.143 CUT-OFF 4.28 differs from the reported value 3.1 by more than 10 %
