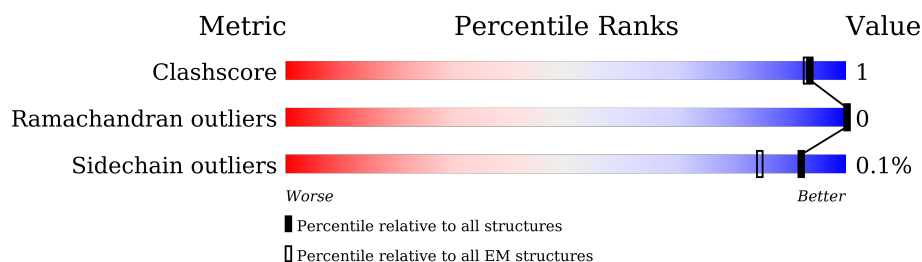
1 Overall quality at a glance

The following experimental techniques were used to determine the structure:

ELECTRON MICROSCOPY

The reported resolution of this entry is 13.50 Å.

The numeric value for each fraction is indicated below the corresponding segment, with a dot representing fractions $\leq 5\%$. The upper red bar (where present) indicates the fraction of residues that have poor fit to the EM map (all-atom inclusion $< 40\%$). The numeric value is given above the bar.

2 Entry composition

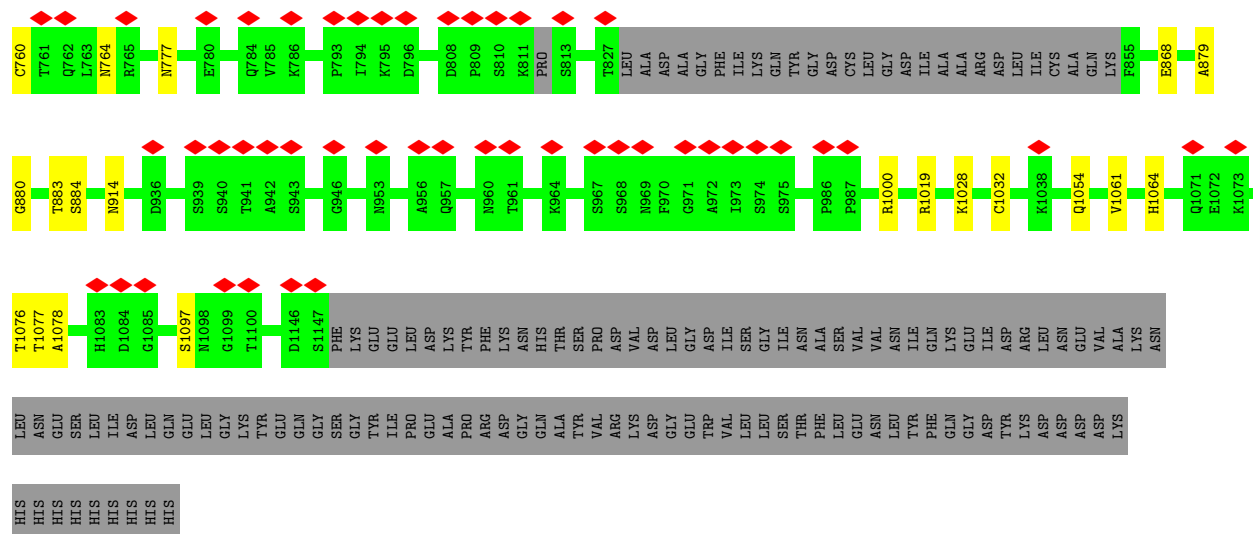

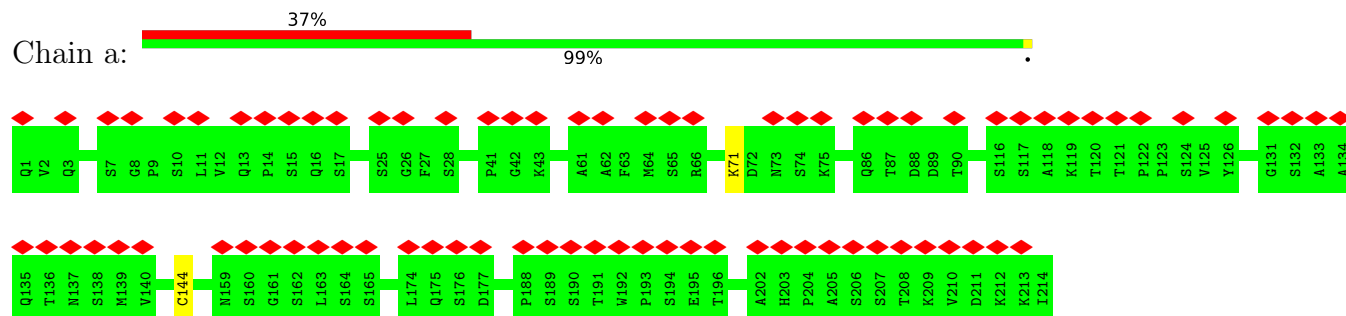

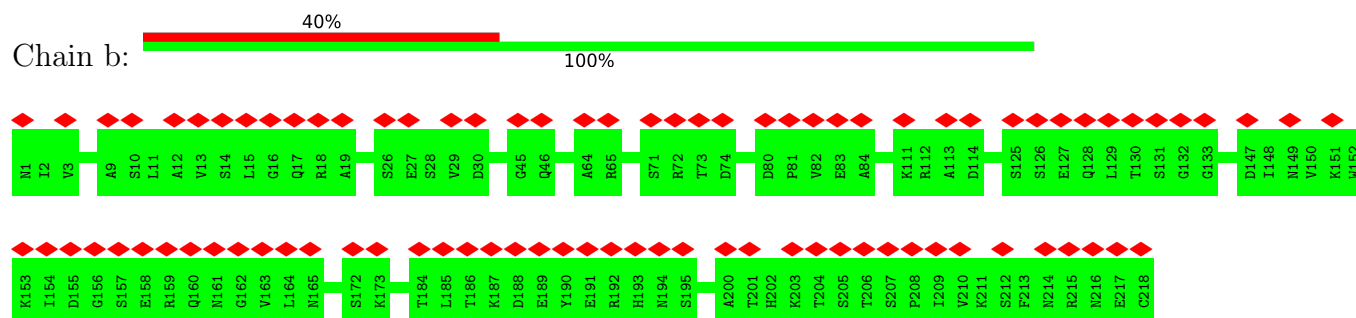

5.2 Too-close contacts [i](#)

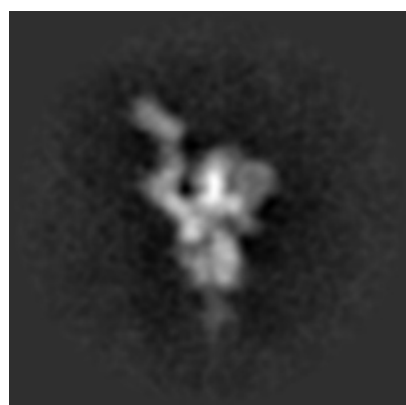

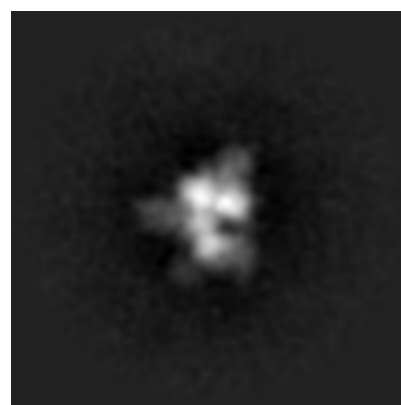

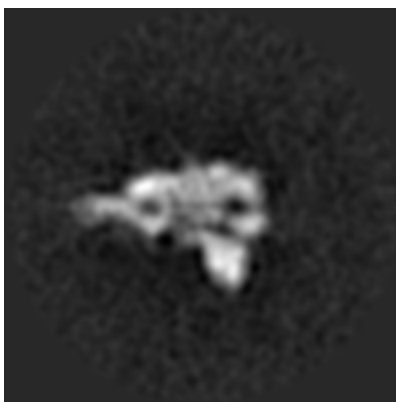

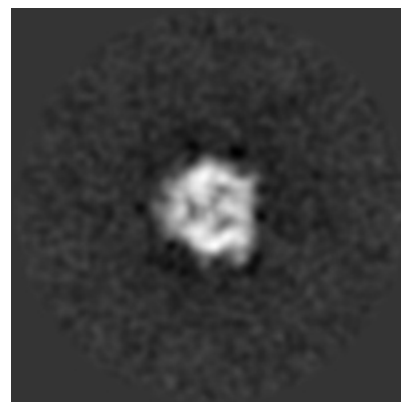

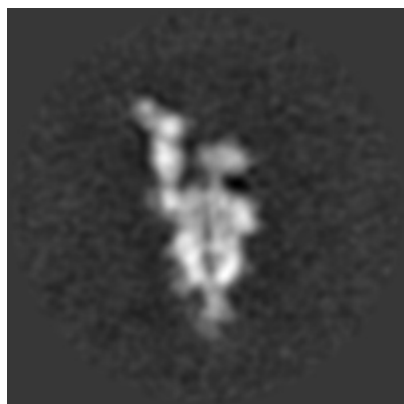

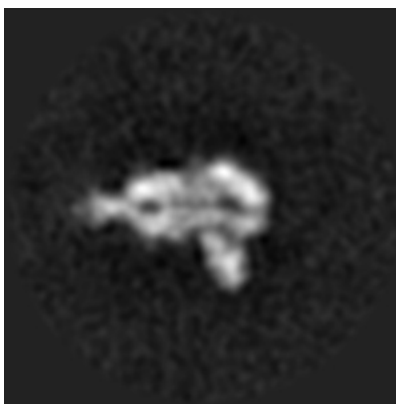
The images above show central slices of the map in three orthogonal directions.

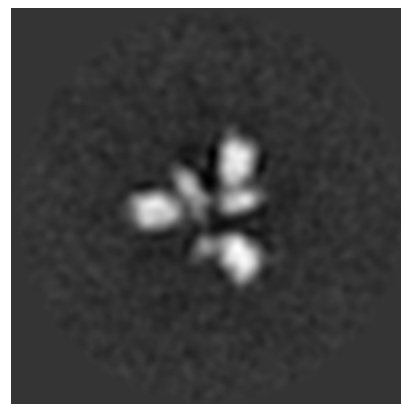

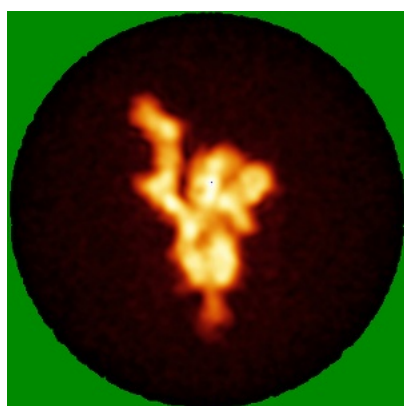

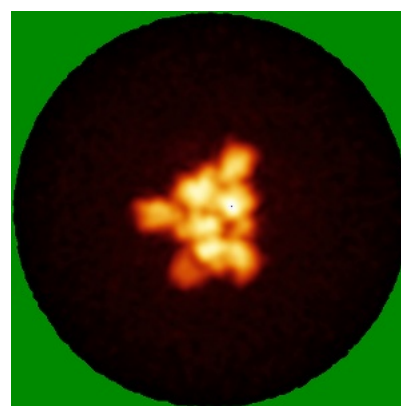

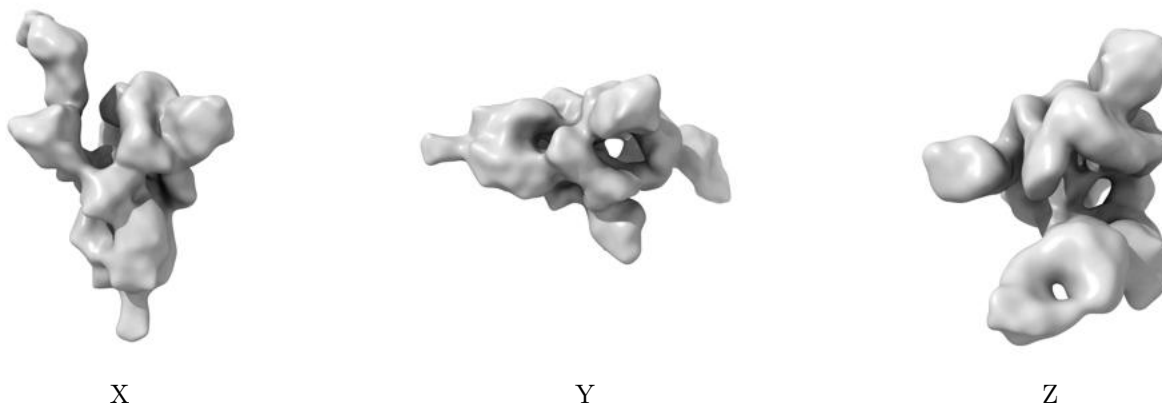

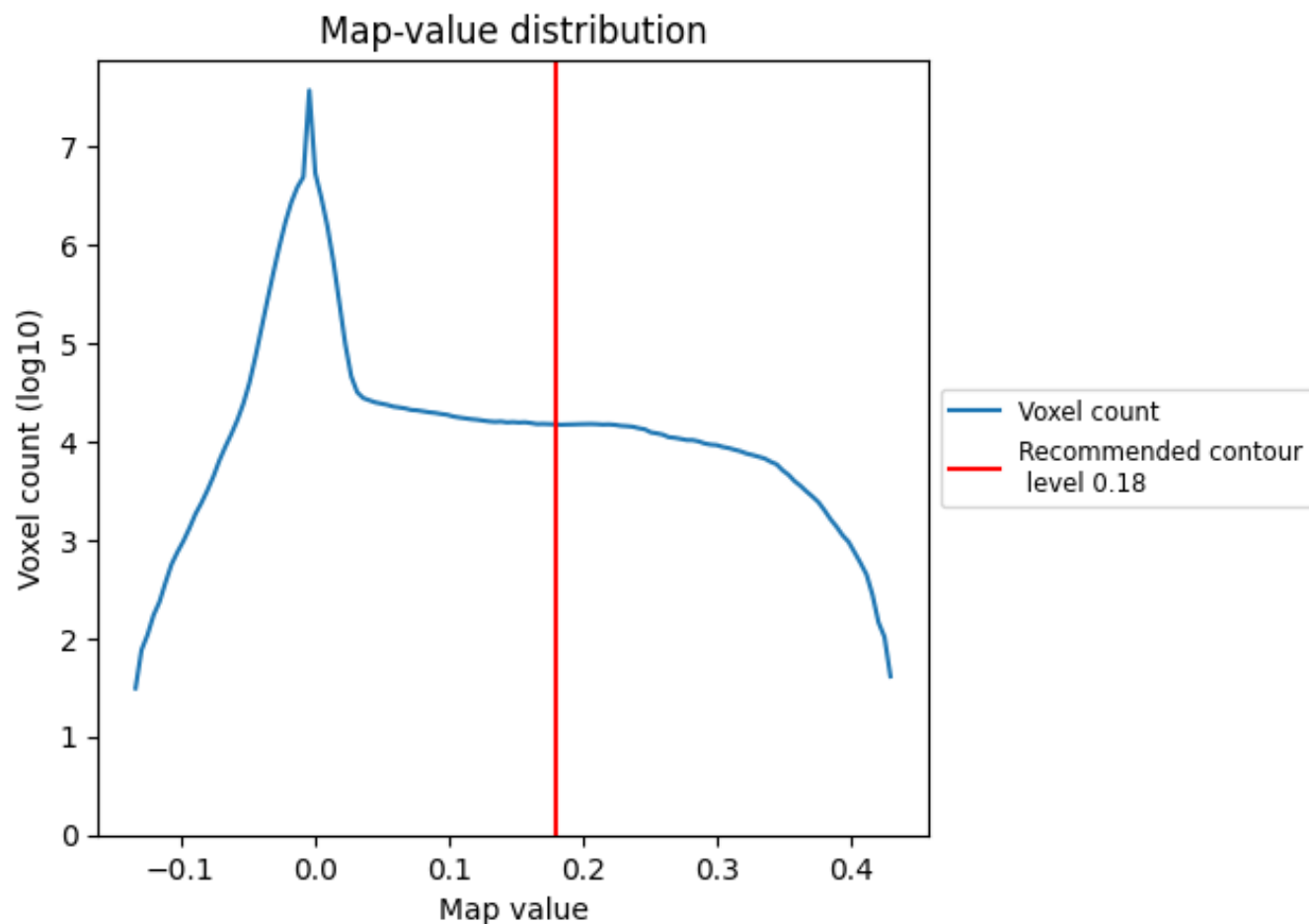

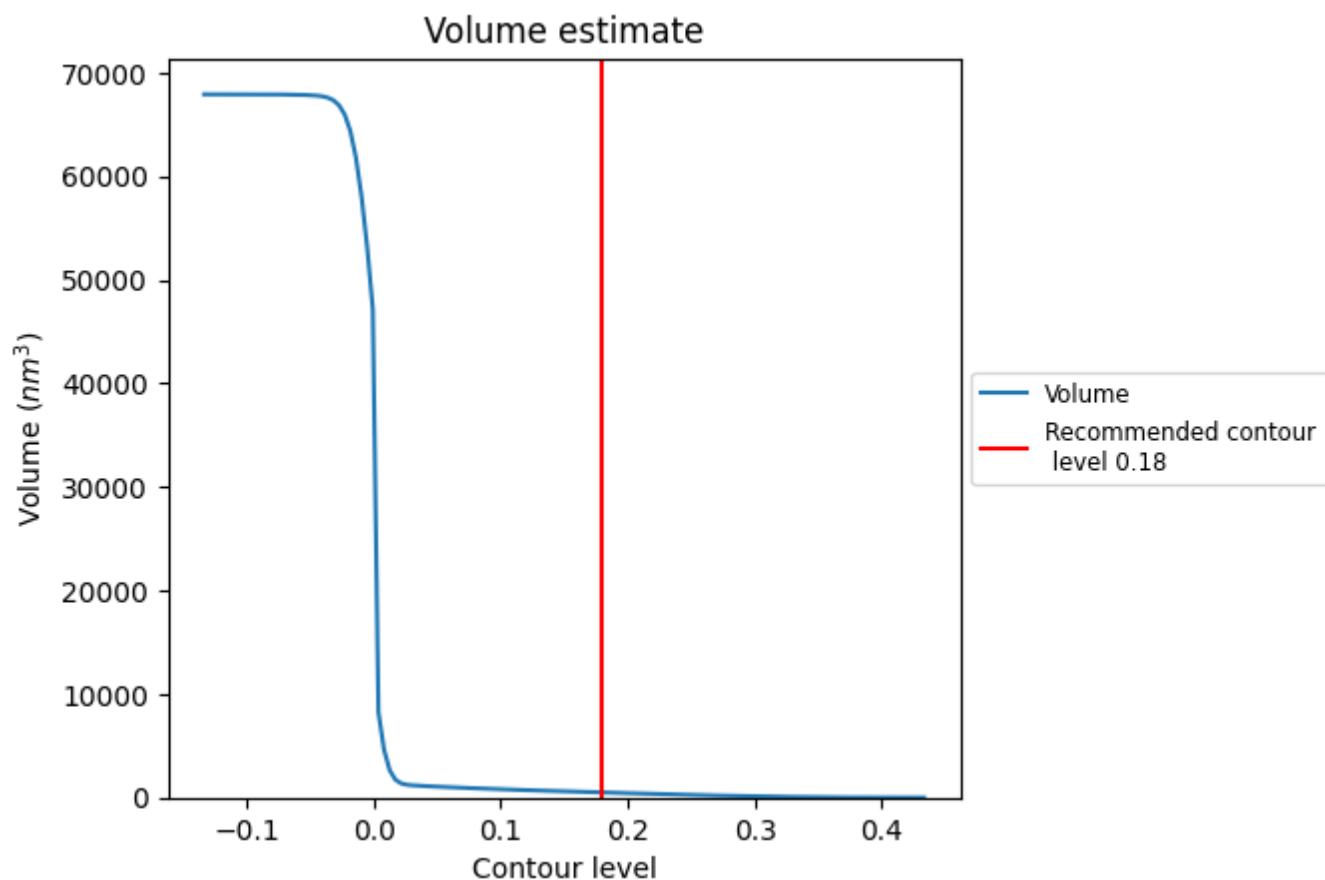

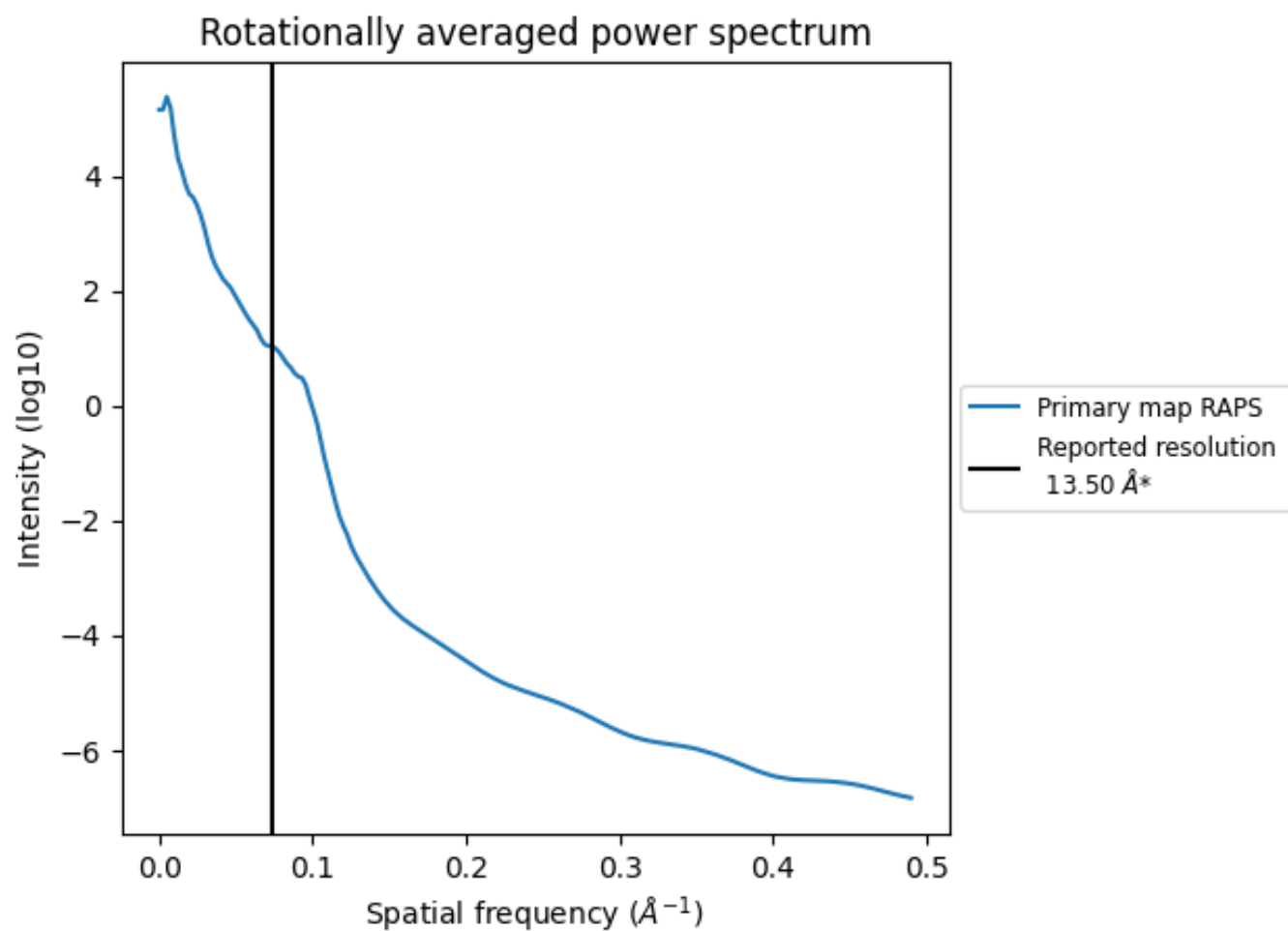
7.2 Volume estimate [i](#)

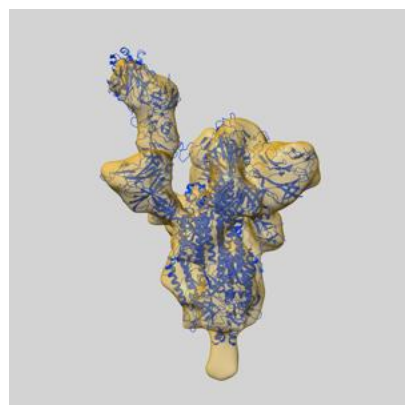

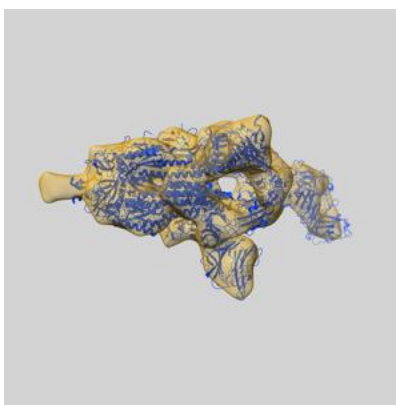

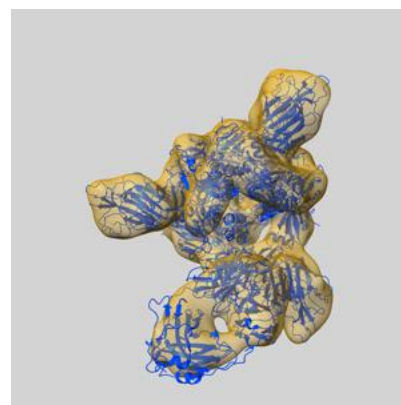

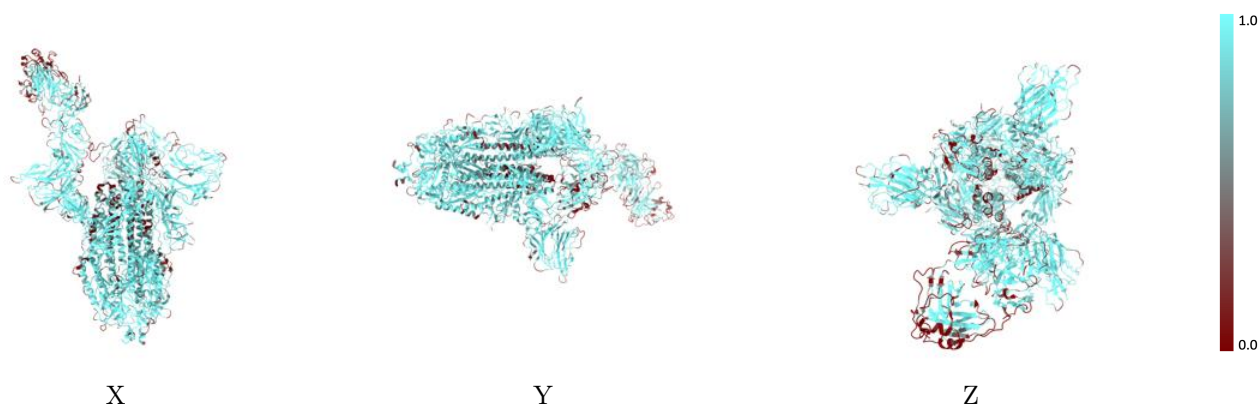

9.2 Q-score mapped to coordinate model [i](#)



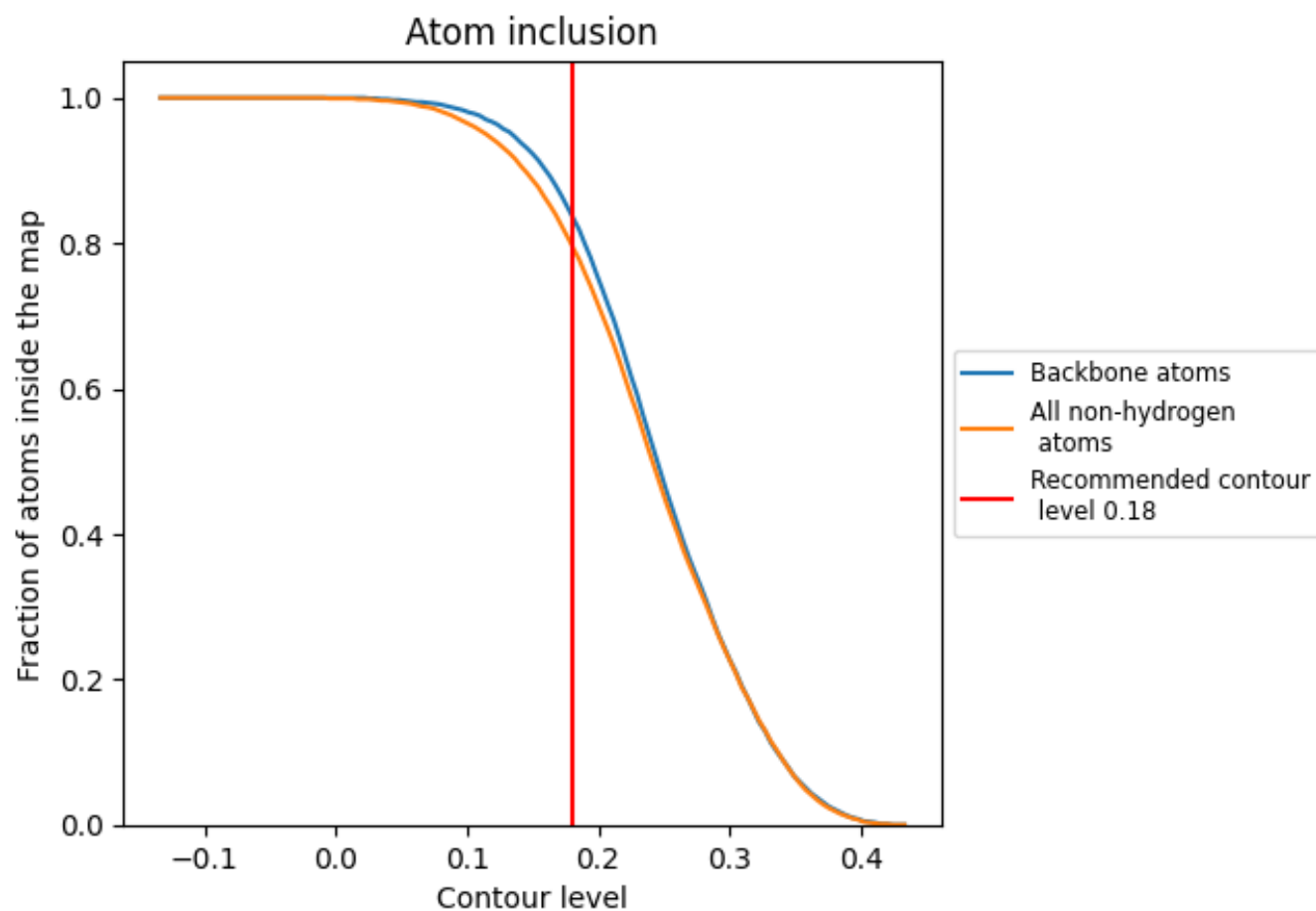

Please note: Q-score is calculating the resolvability of atoms, and thus high values are only expected at resolutions at which atoms can be resolved. Low Q-score values may therefore be expected for many entries.

9.3 Atom inclusion mapped to coordinate model [i](#)



The images above show the model with each residue coloured according to its atom inclusion. This shows to what extent they are inside the map at the recommended contour level (0.18).

9.4 Atom inclusion ⓘ



At the recommended contour level, 84% of all backbone atoms, 80% of all non-hydrogen atoms, are inside the map.
