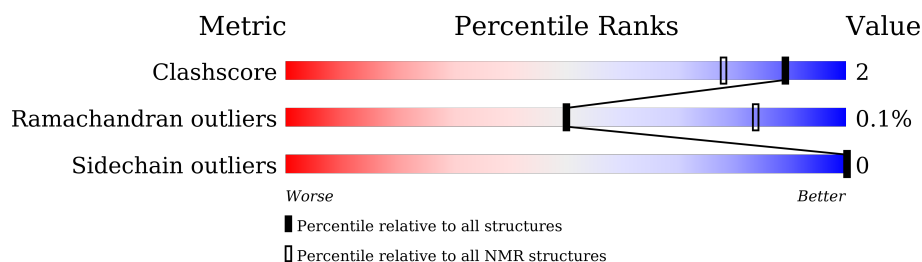
# 1 Overall quality at a glance

The following experimental techniques were used to determine the structure:

*SOLUTION NMR*

The overall completeness of chemical shifts assignment is 71%.

Percentile scores (ranging between 0-100) for global validation metrics of the entry are shown in the following graphic. The table shows the number of entries on which the scores are based.

The table below summarises the geometric issues observed across the polymeric chains and their fit to the experimental data. The red, orange, yellow and green segments indicate the fraction of residues that contain outliers for  $\geq 3$ , 2, 1 and 0 types of geometric quality criteria. A cyan segment indicates the fraction of residues that are not part of the well-defined cores, and a grey segment represents the fraction of residues that are not modelled. The numeric value for each fraction is indicated below the corresponding segment, with a dot representing fractions  $\leq 5\%$

## 2 Ensemble composition and analysis

This entry contains 10 models. Model 10 is the overall representative, medoid model (most similar to other models). The authors have identified model 1 as representative, based on the following criterion: *lowest energy*.

The following residues are included in the computation of the global validation metrics.

Ill-defined regions of proteins are excluded from the global statistics.

Ligands and non-protein polymers are included in the analysis.

The models can be grouped into 2 clusters and 3 single-model clusters were found.

### 3 Entry composition

There is only 1 type of molecule in this entry. The entry contains 1531 atoms, of which 761 are hydrogens and 0 are deuteriums.

- Molecule 1 is a protein called Double-stranded RNA-binding domain (DsRBD)-containing protein.

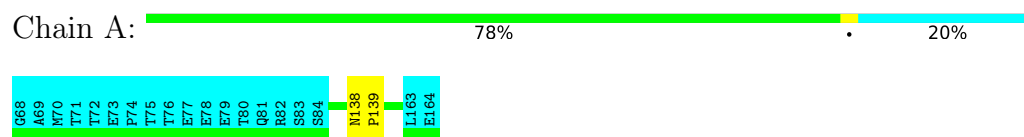

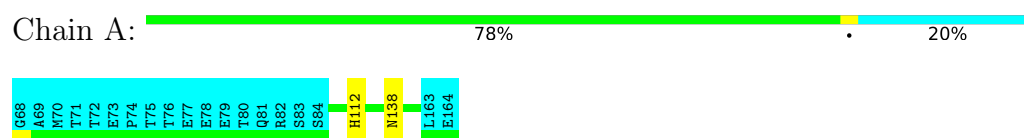

- Molecule 1: Double-stranded RNA-binding domain (DsRBD)-containing protein



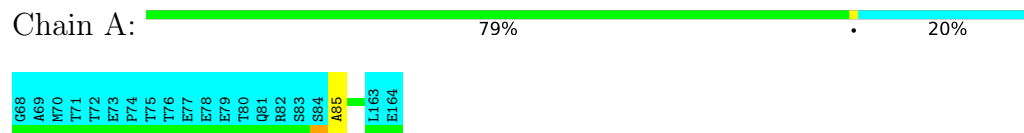

- Molecule 1: Double-stranded RNA-binding domain (DsRBD)-containing protein



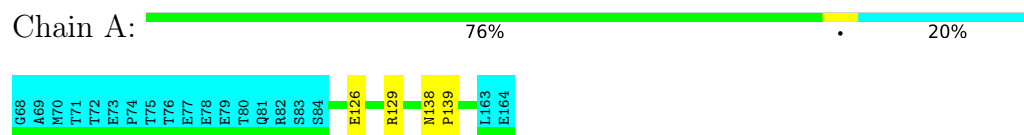

- Molecule 1: Double-stranded RNA-binding domain (DsRBD)-containing protein



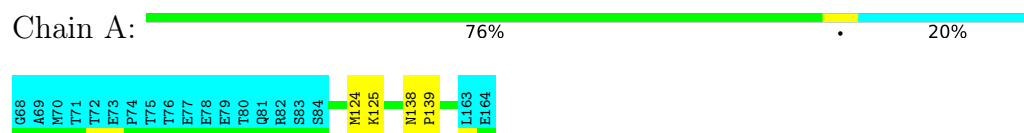

- Molecule 1: Double-stranded RNA-binding domain (DsRBD)-containing protein



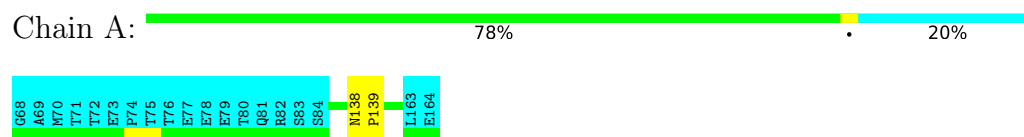

- Molecule 1: Double-stranded RNA-binding domain (DsRBD)-containing protein



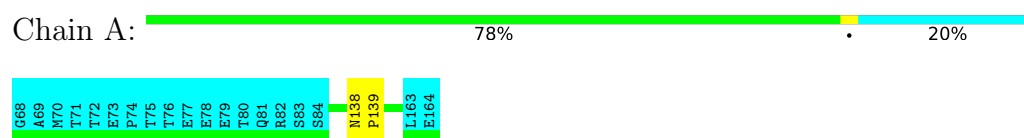

- Molecule 1: Double-stranded RNA-binding domain (DsRBD)-containing protein



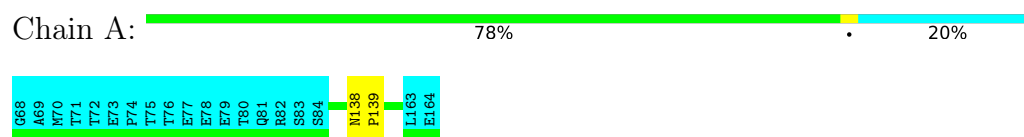

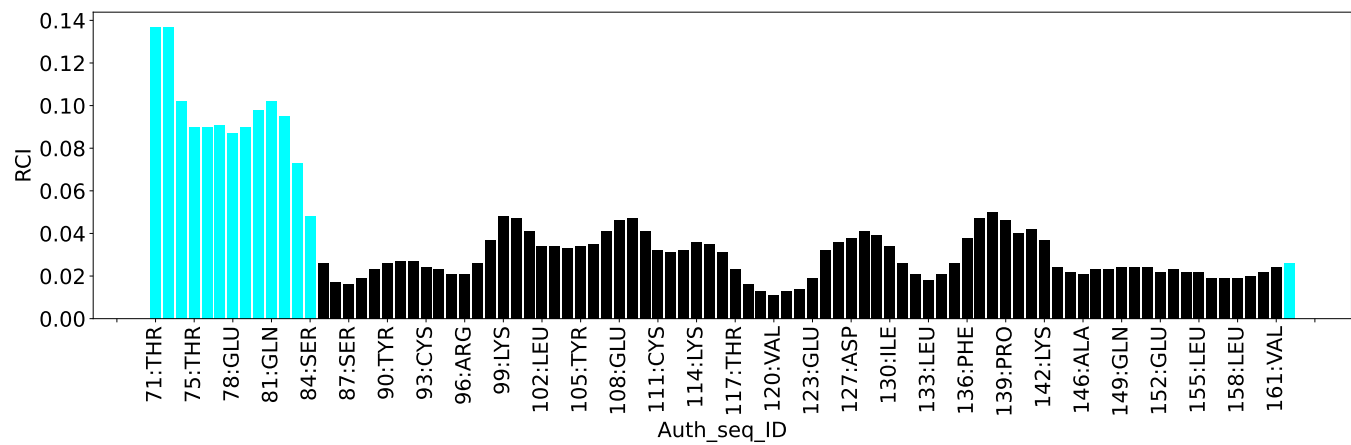

#### 7.1.5 Random Coil Index (RCI) plots [i](#)

The image below reports *random coil index* values for the protein chains in the structure. The height of each bar gives a probability of a given residue to be disordered, as predicted from the available chemical shifts and the amino acid sequence. A value above 0.2 is an indication of significant predicted disorder. The colour of the bar shows whether the residue is in the well-defined core (black) or in the ill-defined residue ranges (cyan), as described in section 2 on ensemble composition. If well-defined core and ill-defined regions are not identified then it is shown as gray bars.

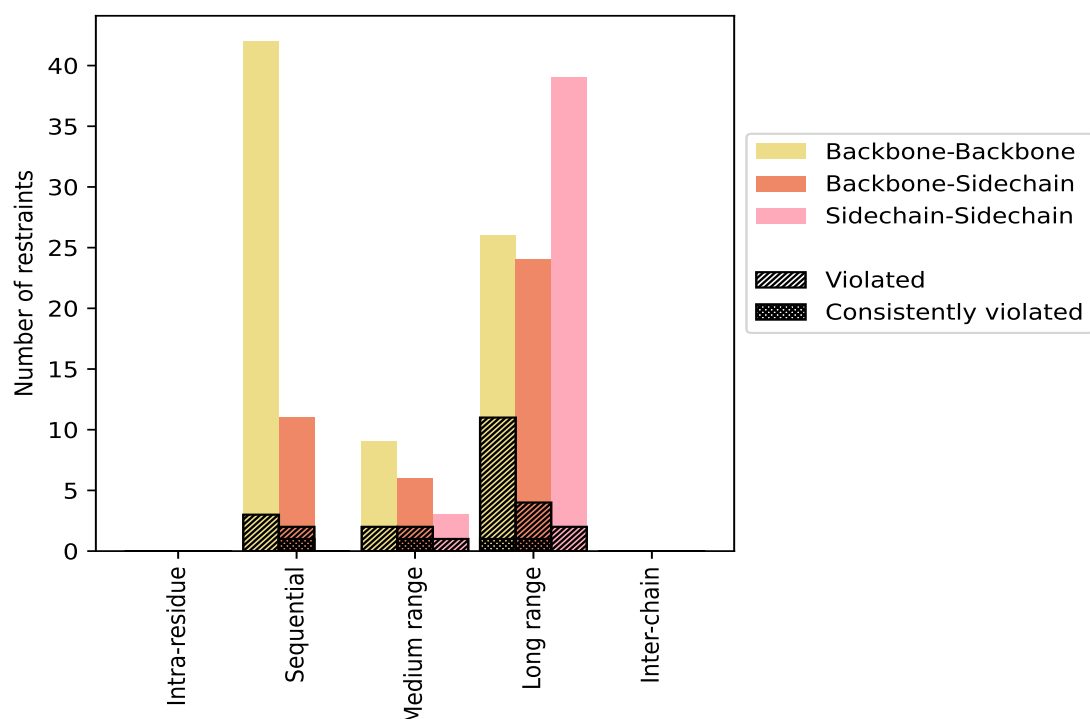

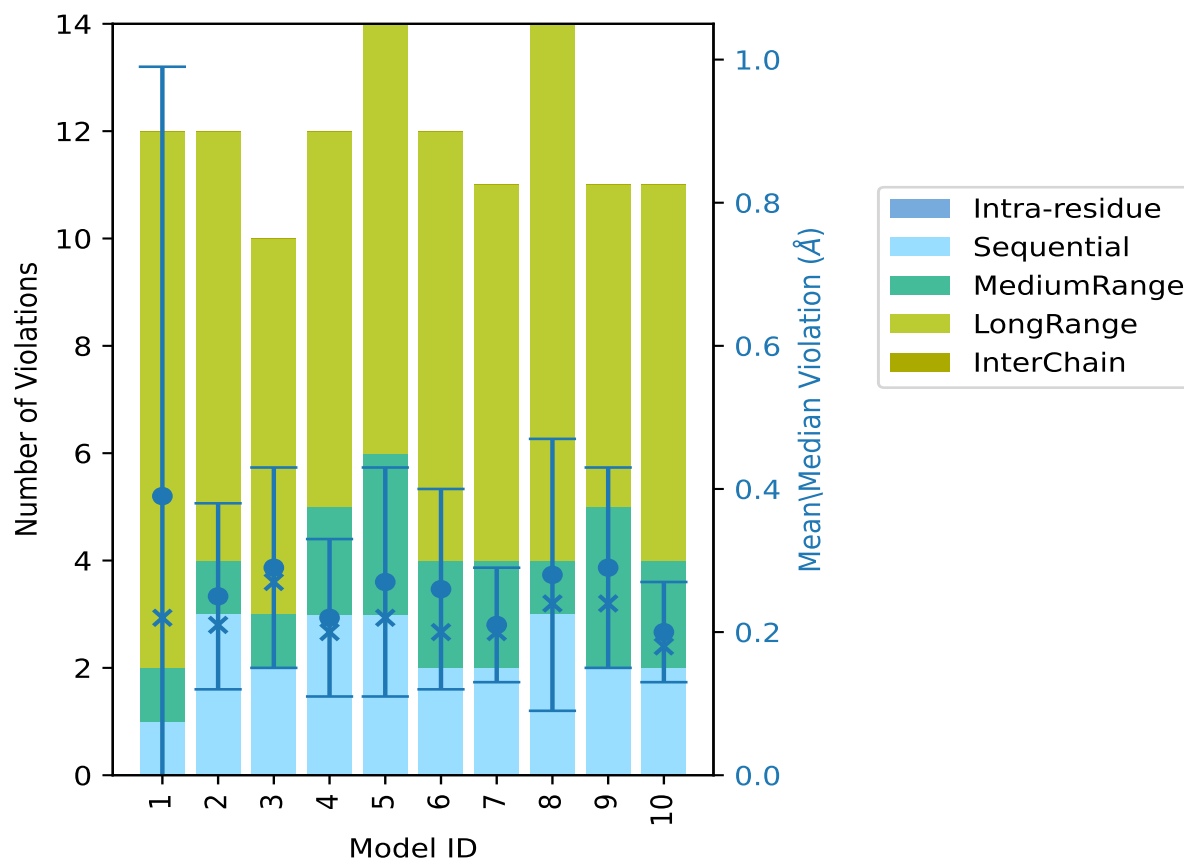

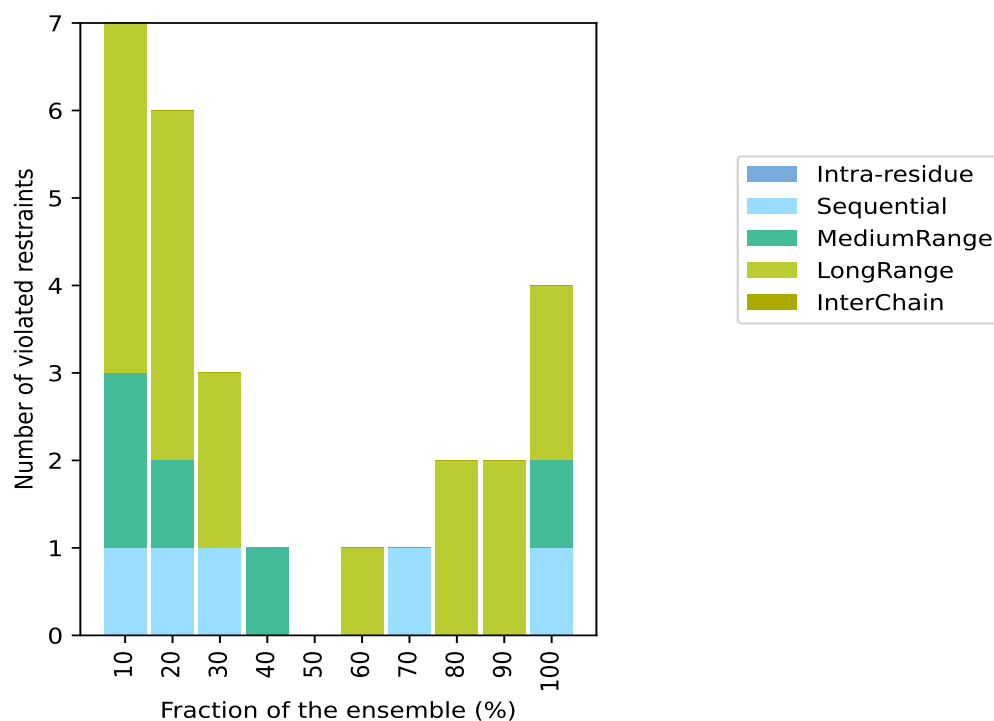

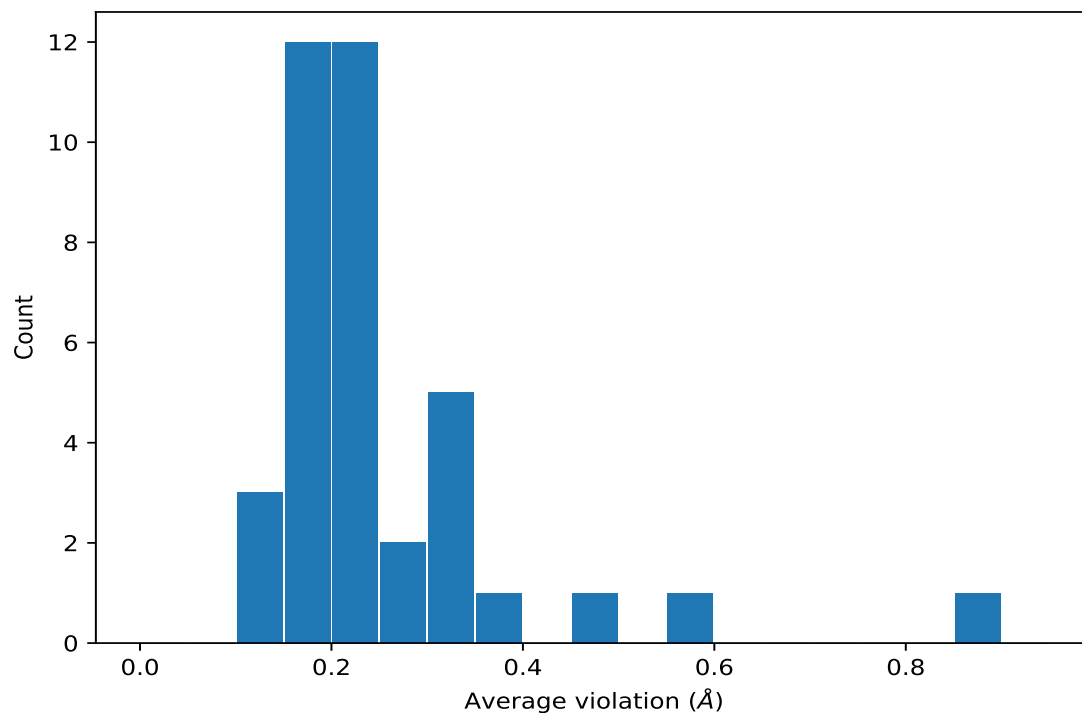

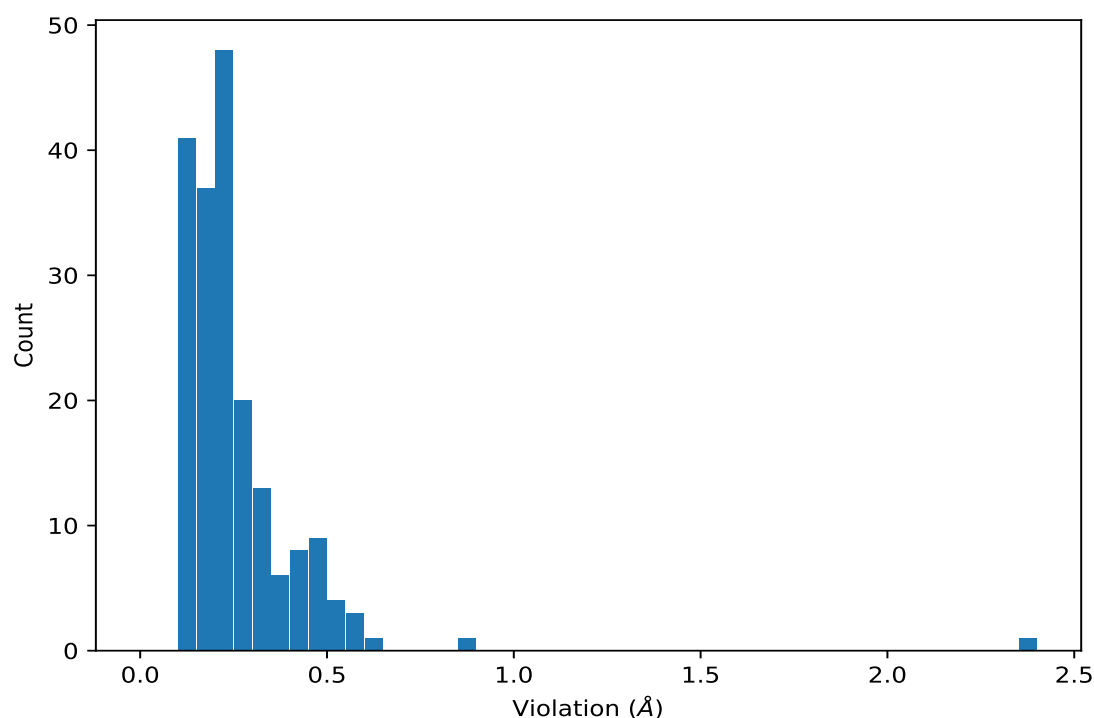

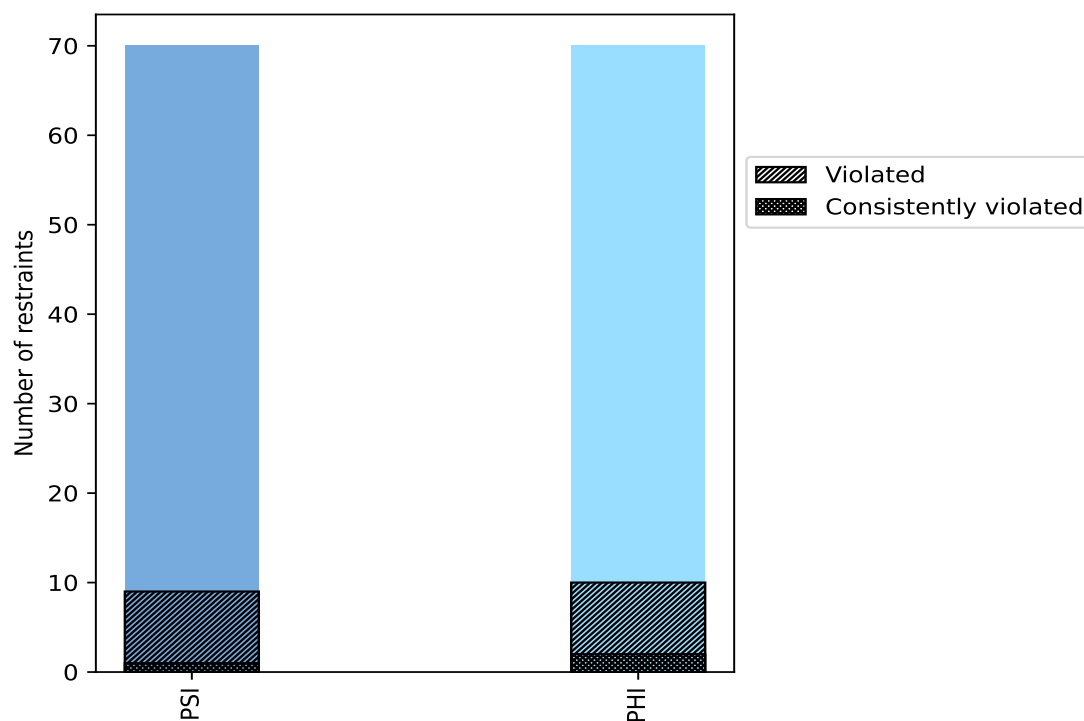

#### 10.1.1 Bar chart : Distribution of dihedral-angles and violations [i](#)



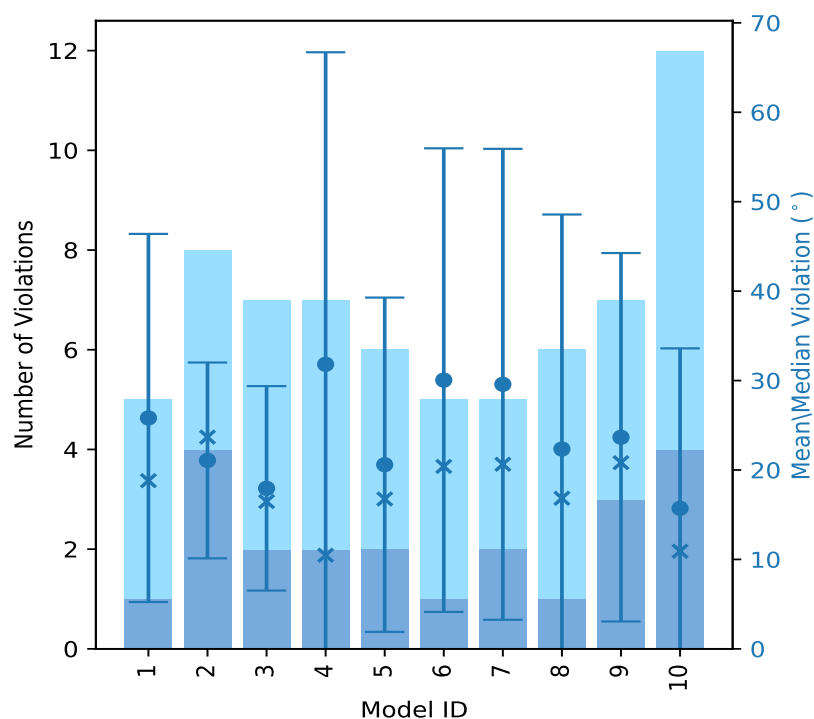

The mean(dot),median(x) and the standard deviation are shown in blue with respect to the y axis on the right

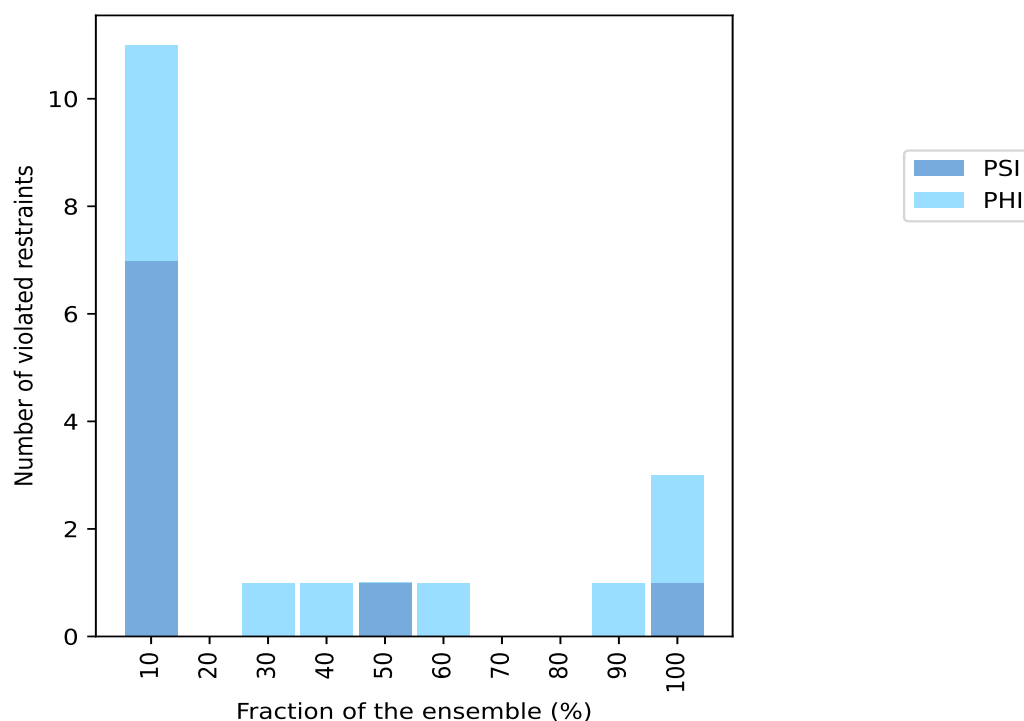

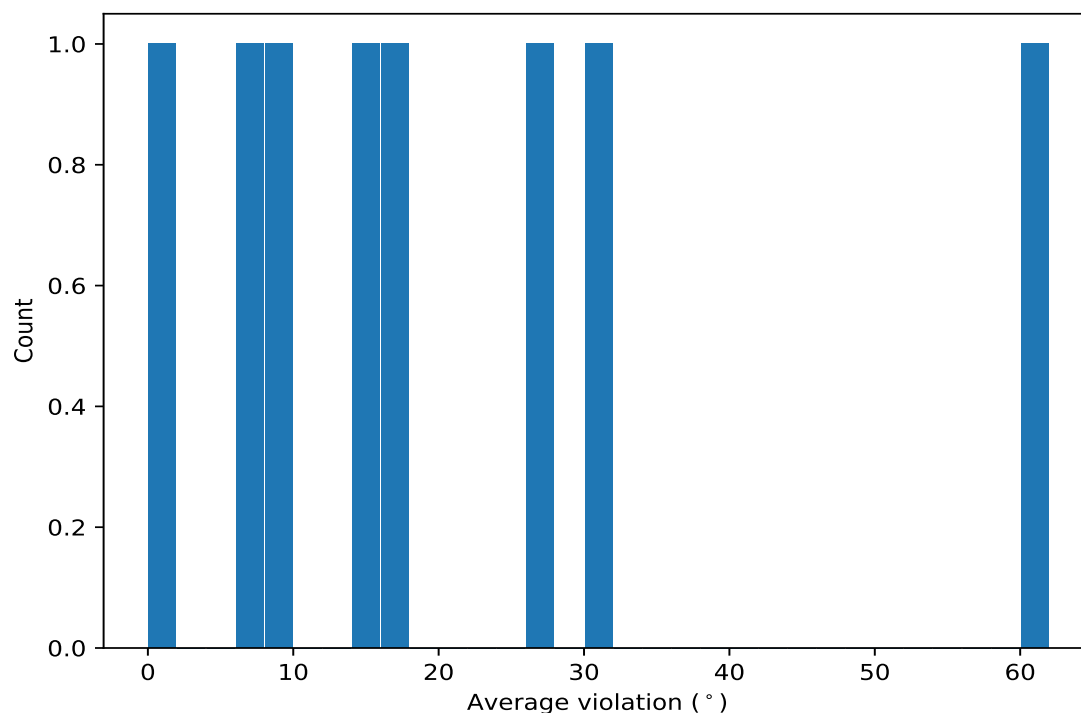
#### 10.3.1 Bar graph : Dihedral-angle Violation statistics for the ensemble [i](#)

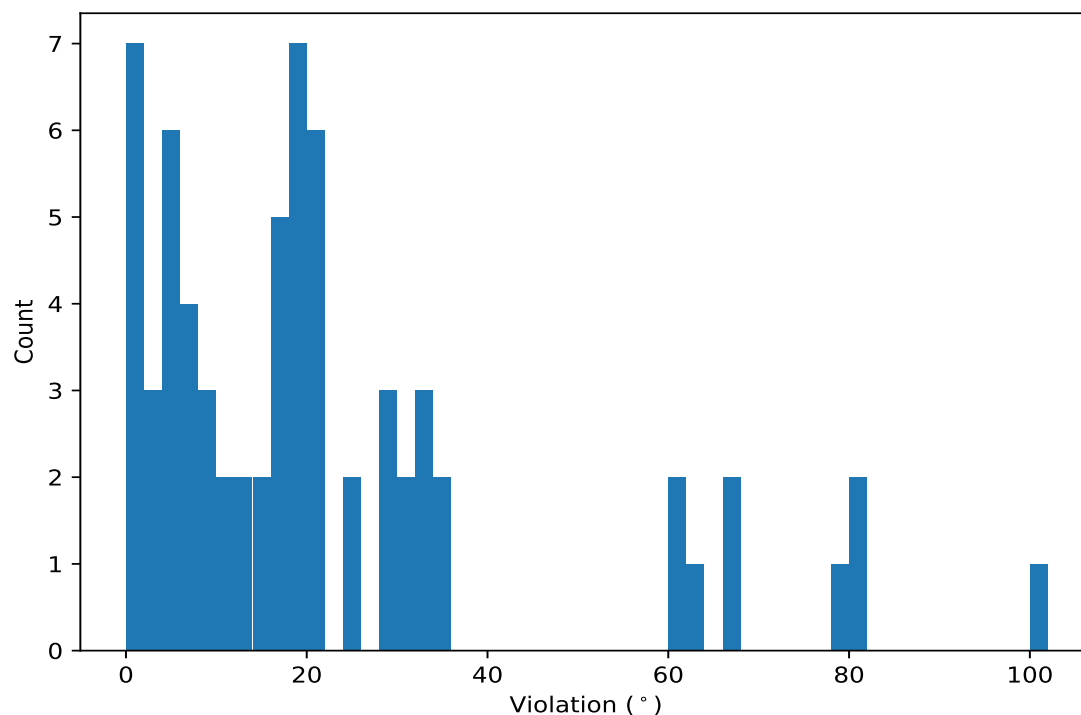
